

## LEONARD LEGACY AWARD

**Overview:** Merry Leonard has served as a MUD Director since the mid 70s. Leonard was elected to the AWBD Board of Trustees in the early 80s and served in various offices, including President. In 1993, she was hired as the AWBDs first full-time employee and was later named Executive Director. Although, she retired from AWBD in 2020, she continues to serve on a MUD. Leonard has always believed in the value of service and the power of districts and their directors to make positive and enduring impacts on their communities. The Leonard Legacy Award honors Merry and all water district directors who champion districts' efforts that make their parts of the world better.

### ***Timeline:***

- Nominations are due by Monday, April 10, 2023.
- Finalists will be announced on Wednesday, May 10, 2023 (AWBD May Board Meeting)
- The Leonard Legacy Award will be announced on Saturday, June 24, 2023, at Awards Luncheon.

### ***Nominations:***

- AWBD will send Member Consultant Firms ("Member Firm") nomination forms.
- Nominations must be sent to [info@awbd-tx.org](mailto:info@awbd-tx.org); to preserve the integrity of the nominations process *do not* send applications to any recipient or address.
- AWBD staff will accept the *first two* nominations by a Member Firm (confirming receipt) and will reject subsequent applications.
- Nominations are anonymous and confidential. The identity of the nominating firm will not be disclosed by AWBD to anyone other than AWBD staff. AWBD staff will provide the nomination forms without the coversheet to AWBD's judges.
- Nomination applications for the award will be considered for an additional 2 years beyond original submission.

**Criteria:** To be eligible for the Leonard Legacy Award, the nominee must:

- Be a current Board Member on an AWBD Member District;
- Have served as a director for at least 10 total years on one or more water district boards;
- Have championed as a director (not a consultant) one or more district initiatives that provided positive, enduring impacts on the community that the district(s) serves;
- Have exhibited outstanding character, setting a high bar in personal and professional conduct and demonstrating the value of service in the community; and
- Not be a current AWBD employee nor AWBD Board Member.

**Judging Panel:** A judging panel selected by the AWBD Recognition Committee and confirmed by the AWBD Board of Trustees will:

- Review and score the nomination packets provided by AWBD staff using a voting rubric approved by the Recognition Committee;
- As a panel, narrow the nominations to three finalists; and
- Submit a vote by secret ballot to Sherri Greenwood for the Leonard Legacy Award.
